

DOCUMENTS TO BE PROVIDED BY THE CLAIMANT AND SPOUSE

- A full copy of the last tax assessment (or tax exemption) issued during 2023 regarding income for 2022.
- For your spouse
 - If you live in Monaco:
 - ✓ a copy of the back/front of the Monegasque identity card or resident card.
 - ✓ proof of income on payment of securities and investments in 2022 for each member of the couple.
 - If you live in France:
 - The life certificate for your spouse, dated within at least one month.*
 - If you live in Italy:
 - ✓ "lo stato di famiglia" dated within at least one month
 - If you live abroad:
 - The life certificate for your spouse, dated within at least one month.*
 - \checkmark The residence certificate for your spouse, dated within at least three months.*

* <u>Only certificates drawn up by a town hall, consulate, police station, notary or a doctor will be considered as valid</u>.

For retirees

For each pension from a general social security scheme or a personal scheme, an annual certificate stating the amount received (or a copy of your notification):

- Monaco retirement pension (government, CHPG...):
- Retirement pension from France (C.A.R.S.A.T., C.N.A.V., personal scheme, military retirement pension...)
- Retirement pension from Italy (I.N.P.S., personal scheme, military retirement pension...)
- Retirement pension from another foreign country.

For each supplementary retirement pension (Monegasque, French, Italian or other), an annual certificate stating the amount received.

- For those receiving a disability pension or a workplace accident allowance An annual certificate stating the total amount of the pensions or allowances paid.
- For those receiving an annuity An annual certificate stating the amount received.
- For salaried individuals, civil servants or State officials A certificate stating the total amount of the net salaries received, all bonuses included.
- For liberal professions, craftsmen, shopkeepers, managers, general partners or partners or owners of company shares
 A copy of the last simplified balance sheet.
- For those receiving unemployment benefits A copy of the annual payment notification of unemployment benefits or the last payment notification.
- For those who have received investment income (savings account interest, bonds, shares, life insurance...) that does not appear on the tax assessment
 A statement drawn up by your(s) bank(s) for each individual in the couple.
- For owners of one or several properties in Monaco or abroad Any supporting documents related to the annual amount of any rent received (tax declaration for land income, etc.).
- If you receive or have received welfare-type benefits Please provide proof of payment of the benefit(s)
- Any supporting documents stating a change in situation or income for yourself or your spouse.

IMPORTANT: Supporting documents in a foreign language must be translated into French. The original must be accompanied by a French translation produced by a certified translator or interpreter.

THE PRODUCTION OF ADDITIONAL SUPPORTING DOCUMENTS MAY BE REQUESTED DURING THE PROCESSING OF THE CASE
